Dear Ho Yi Lau,

RE: CHEMPROCID

This is in reference to your e-mail of March 30, 2023, wherein you requested our opinion on the acceptability of the subject product for use as a sanitizer in food processing establishments.

Based on the information submitted, we have no reason to object to the use of this product as a hard surface food contact sanitizer without a subsequent potable water rinse in food processing establishments, provided that:

- a) There will be no contamination of food as a result of its use and storage;
- b) The food contact surfaces should be hard and non-porous in nature;
- c) The food contact surfaces should be previously cleaned and rinsed with potable water prior to sanitizing;
- d) Prior to application (spraying) of the product in food handling areas, all food should either be removed from the vicinity or otherwise protected;
- e) The concentration of available active quaternary ammonium compounds **will not exceed 200 ppm**; and
- f) The surfaces should be thoroughly drained to remove excess residues of the sanitizing agent prior to re-use of the surfaces and/or equipment in food processing operations.



Disinfectant Claim

Products that are intended to be used as disinfectants on hard food contact surfaces in food processing establishments and having a therapeutic effect (preventing or controlling diseases), are **drug**. Such applications require a **Drug Identification Number (DIN)** registration that is under consideration of the **Natural and Non-Prescription Health Products Directorate (NNHPD)** of Health Canada.
